Neglect Champions Forum—24th October

What is a reflective space session?

- Support staff to feel contained and enabling them to have a secure base
- Build confidence in staff to be reflective and professionally curious
- Build emotional intelligence in staff

Joint Agency Group Supervision (JAGS)

The NSCP have recently announced the launch of the revised model of Joint Agency Group Supervision (JAGS).

The Norfolk Safeguarding Children Partnership has recently undertaken some work to scrutinise how JAGS were operating and found that in practice many JAGS had strayed from the fidelity of the model becoming more like a professional meeting with a focus on case management (sometimes called a Team Around the Child Supervision or TACS) - the core purpose of a JAGS had been lost.

As a reminder, the purpose of a JAGS is to provide a reflective safe space for multiagency practitioners where the very challenging work of safeguarding children, and the emotional impact of this work, is understood, contained and held. It is well documented in research and Child Safeguarding Practice Reviews, that if we are to collectively safeguard children we must support our most precious resource – <u>you</u> – by providing a safe space to pause and reflect together.

Much work has now been completed to return JAGS to the fidelity of the model. There is a <u>revised procedure</u>, practice guidance and a pool of multi- agency practitioners trained to be independent JAGS facilitators and provide a consistent experience for participants. The process of requesting a JAGS has been centralised through the NSCP who will manage the process of requesting a JAGS and appointing an independent JAGS facilitator – only those who have been trained will be appointed to facilitate a JAGS.

Anyone in the Norfolk Children's workforce can request a JAGS. Please take a minute to read the revised guidance and use this MS Form if you would like to request a JAGS.

JAGS can be a valuable space for thinking through neglect cases where people might feel stuck or need some containment. As Neglect Champions this is an opportunity to identify potential cases where additional support may be required.



Enhanced Family Help Team

The new Enhanced Family Help Team are very excited to be working together with children and families across the county where there are multiple siblings and sustained issues of neglect. Their aim is to work collaboratively, intensively and over a sustained period with children and families to fully understand their needs through building consistent relationships and providing bespoke interventions. They will be working alongside all our internal and external partners to support families to make achievable plans for the short and long term and addressing multiple needs for support to reduce risk and improve outcomes for the future.

A key part of delivering this support will be through collaborative working with our partner agencies so that the needs of individual children and the whole family are understood. Through consistent conversation and the sharing of key information, the whole network will work together, providing knowledge to support identification of needs which will support the development of targeted family plans. In essence, a whole system approach which means less drift, cross over of interventions and ultimately better outcomes for all.

The team have already made contact with many of our partners, with conversations and early plans about how we can best work together and build relationships underway. Currently the team will be working with families who are already within the Child Protection arena, however the team are happy to be contacted via email for information, advice, or support, and would be happy to meet with any partners to share development, training and knowledge moving forward so we can tackle Neglect for our Norfolk Children and their families together.

Adolescent Graded Care Profile

A version of the Graded Care Profile tool which is focused specifically on the needs of adolescents between the age of 13 and 17 is currently under development for use in Norfolk. The development of the tool is being lead by Jenny Sproule from Children's Services under the direction of the Ways of Working Subgroup of the Neglect Strategy Implementation Group.

A trial of the tool will take place in the City and South localities in Spring 2025. Evaluation will then take place in order to inform next steps, including a version for use specifically with adolescents themselves.


Wider roll out of the tool across Norfolk is anticipated to happen in Summer 2025.



Harmful Sexual Behaviour and Neglect

Some of the well established impacts of neglect are well established factors in the presentation of young people displaying HSB;


- **Social isolation** limited opportunities to make and explore relationships outside of the family home
- **Inhibited social competency** poor social skills making it difficult to relate to other
- **Disrupted attachments** poor/anti social/unhealthy templates for relationships and what to expect within them. Are relationships safe? Reciprocal? Or unsafe? Transactional?
- **Lack of relationship role models** not seeing healthy relationships in action to build own skills
- **Feeling of inadequacy** lacking the confidence to make healthy relationships, not feeling deserving of relationships/warmth/love
- **Seeking comfort/care** between siblings or sibling adultification as care giver creates relationship confusion
- **Developmental trauma –** lack of safe and secure base from which to confidently explore the world







Harmful Sexual Behaviour and Neglect cont.



In cases of neglect, there is a risk that when HSB in children and young people is also identified, the emphasis of intervention focuses on the HSB, which is the presenting behaviour. This often leads to psycho-education approaches or risk management strategies being put in place as intervention. This means that there is a risk of failure to address the broader life goals and needs of the child, both in the present and future.

The emphasis of professional's intervention needs to be on the systems the child operates in to create safety, security and predictability there, so the child's needs are being met and they no longer require the HSB to communicate their needs.

Risk reduction focuses on supporting the child to meet their needs, building on strengths and capabilities to create skills where there are gaps as a result of neglect.

So HSB can be seen as a potential indicator of neglect, reminding professionals to be curious about the function of the HSB in the context of what we know about the links between neglect and HSB.

Professionals also need to hold in mind that children who have experienced neglect but are not currently displaying HSB will require support to build relationship skills in order to mitigate the risk of them struggling in their healthy sexual development.

This is a multi-agency group who are tasked with facilitating the roll out of the Neglect Strategy and ensuring that its policies are implemented. The Neglect Strategy Implementation Group (NSIG) is made up of representatives from across the safeguarding children partnership.

NSIG will be working on a report evaluating the impact of the strategy over the next six months and presenting this at the next NSCP Priority Review Workshop in 2025.
